



GUIDELINES ON THE EVALUATION AND GRANTING OF CPD CREDIT UNITS TO REGISTERED AND LICENSED PROFESSIONAL TEACHERS WHO PROVIDED ESSENTIAL SERVICES DURING THE STATE OF PUBLIC HEALTH EMERGENCY DUE TO CORONA VIRUS DISEASE 2019 PURSUANT TO COMMISSION RESOLUTION NO. 1239 (S.2020)

WHEREAS, the Commission issued Resolution No. 1239 (s.2020) entitled "Granting Continuing Professional Development (CPD) Credit Units to All Professionals Providing Essential Services during the State of Public Health Emergency due to Corona Virus Disease 2019 (COVID-2019)", which provides for the guidelines on how professionals can earn CPD credit units; and

**WHEREAS**, the said guidelines mandated all CPD Councils to issue their respective rules on the evaluation of the applications based on the following, but not limited to, duration or period of engagement or services rendered and the nature of the assignment or task.

**NOW THEREFORE**, the CPD Council for Professional Teachers **RESOLVES** to issue these guidelines on the evaluation and granting of CPD credit units to professionals pursuant to Commission Resolution No. 1239 (s.2020), as follows:

**Section 1. Matrix of Activities Conducted by professionals.** The following is the matrix of activities conducted by all professionals who provided essential services during the State of Public Health Emergency brought about by the COVID-19 crisis:



WHEREAS, the Commission issued Resolution No. 1208 (s. 2019) or the Guidelines on the Accreditation of Informal and Professional Work Experience and, Section 5 thereof states that the Continuing Professional Development (CPD) Councils shall determine the appropriate number of CPD credit units;

**WHEREAS**, the commission issued Resolution No. 1240, s. 2020 reiterating ways of learning that can earn Continuing Professional Development (CPD) credit units particularly during the state of public health emergency due to the COVID – 19 crisis;

WHEREAS, there is need to issue guidelines in order to guide the Professionals on the evaluation and granting of CPD credit units to activities under Informal Learning and Professional Work Experience including activities undertaken during the state of Public Health Emergency due to the COVID—19 Crisis that may earn CPD credit units.

**NOW THEREFORE**, the CPD Council for Professional Teachers **RESOLVES** to issue these guidelines on the evaluation and granting of CPD credit units to activities under Informal Learning and Professional Work Experience including activities undertaken during the state of Public Health Emergency due to the COVID – 19 crisis that may earn CPD credit units, as follows:

**Section 1. Informal Learning** refers to learning that occurs in daily life and which can contribute to a qualification. The parameters for the evaluation and granting of credit units for informal learning are as follows:

- **Section 4. Repealing Clause -** Any resolution, memorandum order or circular and any issuances inconsistent with these guidelines are hereby repealed or modified accordingly.

**Section 5. Effectivity** — This Resolution shall take effect immediately, copy furnished the U.P Law Center.

# PROFESSIONAL REGULATION COMMISSION Resolution No. 1240 Series of 2020

REITERATING WAYS OF LEARNING THAT CAN EARN CONTINUING PROFESSIONAL DEVELOPMENT (CPD) CREDIT UNITS PARTICULARLY DURING THE STATE OF PUBLIC HEALTH EMERGENCY DUE TO COVID-19 CRISIS AND EXTENDING THE ACCEPTANCE OF UNDERTAKING FOR THE RENEWAL OF THE PROFESSIONAL IDENTIFICATION CARD (PIC) UNTIL DECEMBER 31, 2021

WHEREAS, the Professional Regulation Commission (Commission) is mandated under Republic Act No. 8981 or the "PRC Modernization Act" to perform any and all acts, enter into contracts, make such rules and regulations and issue such orders and other administrative issuances as may be necessary in the execution and implementation of its functions and the improvement of its services;

WHEREAS, Section 3, Article I of Republic Act (R.A) No. 10912 or the CPD Act of 2016 defines Continuing Professional Development or CPD as the inculcation of advanced knowledge, skills and ethical values in a post-licensure specialization or in an inter-or multidisciplinary field of study, for assimilation into professional practice, self-directed research and/or lifelong learning;

WHEREAS, Section 10, Article III of the CPD Act of 2016 states that the CPD is hereby made as a mandatory requirement in the renewal of the Professional Identification Cards (PICs) of all registered and licensed professionals under the regulation of the PRC;

WHEREAS, to ease the renewal of PICs, the Commission during the initial implementation of the CPD Act of 2016 started to accept the Undertaking of professionals who failed to comply with the CPD requirement for the renewal of their PICs "to submit the balance of xxx CPD credit units in addition to the xxx required CPD units (or a total of xxx units) for the next renewal of my PIC". The acceptance of the said Undertaking will end on December 31, 2020;

WHEREAS, due to the Corona Virus Disease 2019 (COVID-19) crisis, the President issued Proclamation No. 922 (s.2020) declaring a State of Public Health Emergency throughout the Philippines and Proclamation No. 929 (s. 2020) declaring a State of Calamity throughout the Philippines;

WHEREAS, the Executive Secretary issued a Memorandum dated 16 March 2020 on the guidelines on the imposition of an Enhanced Community Quarantine (ECQ) and Stringent Social Distancing Measures over the entirety of Luzon;

WHEREAS, Local Government Units in the Visayas and Mindanao regions have likewise imposed quarantine or lockdown measures within their respective jurisdictions through the issuance of various local Executive Orders;

WHEREAS, CPD Providers cancelled the scheduled offerings of their programs, including conventions, conferences and other forms of mass gatherings, which are significant means of CPD compliance by professionals and which may not be available during the COVID-19 crisis;

WHEREAS, other ways of CPD compliance such as self-directed learning activities, informal and professional work experience, and online training activities may also be availed of by professionals;

**WHEREAS**, there is a need to institute measures in order for the professionals to be able to renew their PICs in the event that they fail to comply with the CPD requirement as a result of the foregoing cancellation of CPD Programs by executing said Undertaking;

WHEREAS, the Continuing Professional Development-Program Management Committee (CPD-PMC) recommends to the Commission the reiteration of favorable ways of learning that can earn CPD credit units particularly during the State of Public Health Emergency, and the extension for the acceptance of the Undertaking until December 31, 2021; and

**WHEREAS**, the Continuing Professional Development (CPD) Councils concur and have expressed their full support to the foregoing initiative.

**NOW THEREFORE,** in view of the foregoing, the Commission hereby **RESOLVES**, as it hereby **RESOLVED**, to **ADOPT** the recommendations of the CPD-PMC and the CPD Councils, as follows:

- 1. During the COVID-19 crisis, as professionals are constrained from attending learning activities that entail mass gatherings, to earn credit units due to the imposition of social distancing, they may, however, earn CPD credit units through:
  - a) Informal Learning under Commission Resolution No. 1208 (s.2019) entitled "Guidelines on the Accreditation of Informal Learning and Professional Work Experience" which governs the process and procedure for earning CPD credit units.

Informal Learning refers to learning that occurs in daily life and which can contribute to a qualification. Examples are: 1) Reading of books, magazine journals, and the like that will develop leadership, management, and other skills; 2) Learning how to use cross platform Voice Over Internet Protocol (VOIP) and instant messaging using cloud-based video conferencing tool to meet with co-workers; 3) Learning how to prepare gluten free meals and baked products; and 4) Learning how to do urban gardening for home consumption of organic vegetables and fruits.

b) Professional Work Experience under Commission Resolution No. 1208 (s.2019) entitled "Guidelines on the Accreditation of Informal Learning and Professional Work Experience" which governs the process and procedure for earning CPD credit units.

(PIC) UNTIL DECEMBER 31, 2021

Professional Work Experience refers to any participation that a professional gains while working in a specific field and work place. Examples are: 1) Reading of books, magazine, journals, and the like on how to improve knowledge and skills in the field of professional practice; 2) Learning how to fashion wheelchairs for pediatric patients with special needs; 3) Learning how to design homes for the elderly population; 4) Learning how to design modules for online teaching; 5) Learning ways of collecting and disseminating information to faculty and students who are studying by distance education; and 6) Providing professional consultancy services to clients.

c) **Self-Directed Learning** under Commission Resolution No. 1197 (s.2019) entitled "Guidelines on Self-Directed Learning Creditable Activities" which governs the process and procedure for earning CPD credit units.

**Self-Directed Learning Activities** are the learning activities such as online training, local/international seminar/non-degree courses, institution / company-sponsored training programs, and the like, which did not undergo CPD accreditation but may be awarded CPD units by the respective CPD Council. These activities are driven by one's need and motivation to learn either through a professional activity or volunteer engagement.

- i. **Professional Activity** refers to activity which promotes and facilitates enhancement of knowledge, skills and values as a professional.
- Volunteer Engagement refers to activity done under the ambit of social responsibility, which may or may not directly involve the practice of profession, but may help in the development of the professional in the social milieu.

Professionals shall apply the said activities for accreditation in order to earn CPD credit units. Their applications shall be subjected to evaluation by the concerned CPD Council within fifteen (15) working days from receipt thereof. The Council may request for additional supporting documents from the applicant if deemed warranted.

- d) Online Learning Activities refer to structured or unstructured learning initiatives, which make use of the internet and other web-based Information and Communication Technology solutions. (Section 3(p), Article I of the CPD Act of 2016).
- 2. CPD providers are encouraged to convert their training programs which entail mass gatherings to online trainings to comply with the social distancing requirement during this COVID-19 crisis, in accordance with Commission Resolution No. 1207 (s. 2019) on the guidelines for the accreditation of online training programs.
- The acceptance of the Undertaking is extended to December 31, 2021 to enable professionals who face difficulties or cannot meet the required CPD credit units to apply for the renewal of their PICs.

# PROFESSIONAL REGULATION COMMISSION RESOLUTION NO. 1239 Series of 2020

GRANTING CONTINUING PROFESSIONAL DEVELOPMENT CREDIT UNITS TO ALL PROFESSIONALS PROVIDING ESSENTIAL SERVICES DURING THE STATE OF PUBLIC HEALTH EMERGENCY DUE TO THE CORONA VIRUS DISEASE 2019

**WHEREAS,** Section 6, Article II of Republic Act (R.A.) No. 10912 or the "Continuing Professional Development Act of 2016" enumerates the powers, functions and responsibilities of the Commission and the Professional Regulatory Boards, including the formulation, issuance and promulgation of guidelines and procedures for the implementation of the Continuing Professional Development (CPD) programs;

**WHEREAS,** due to the Corona Virus Disease 2019 (COVID-19) crisis, the President issued Proclamation No. 922 (s.2020) declaring a State of Public Health Emergency throughout the Philippines and Proclamation No. 929 (s. 2020) declaring a State of Calamity throughout the Philippines;

**WHEREAS**, the Executive Secretary issued a Memorandum dated 16 March 2020 on the guidelines on the imposition of an Enhanced Community Quarantine (ECQ) and Stringent Social Distancing Measures over the entirety of Luzon;

WHEREAS, Local Government Units in the Visayas and Mindanao regions have likewise imposed quarantine or lockdown measures within their respective jurisdictions through the issuance of various local Executive Orders:

WHEREAS, amidst this health crisis, there is a need to mobilize all resources in order to augment the potential shortage in the supply of health and other professionals, especially in COVID-19 infected localities throughout the Philippines;

WHEREAS, during this crisis, the Commission recognizes the heroic and indispensable services that professionals have been tirelessly providing in various ways during this period;

WHEREAS, Section 5, Article II of R.A. No. 10912 provides for the nature of the CPD programs which includes Self- Directed Learning (SDL) and Professional Work Experience (PWE). SDL activities are those activities driven by one's need and motivation to learn either through a professional activity such as professional work experience or volunteer engagement. Professional activity promotes and facilitates enhancement of knowledge, skills and values which provides opportunities for achievement of learning outcomes, while volunteer engagement is done under the ambit of social responsibility, which may or may not directly involve the practice of profession, but may help in the development of the professional in the social milieu. On the other hand, PWE refers to any participation that a professional gains while working in a specific field and work place;

**WHEREAS.** the CPD Councils have expressed their full support to the Commission in granting CPD credit units to all professionals providing essential services during the State of Public Health Emergency due to COVID-19 crisis.

**WHEREAS,** all the Professional Regulatory Boards have likewise concurred to authorizing the grant of CPD credit units to professionals in recognition of the tasks and services provided,

**NOW THEREFORE**, the Commission hereby **RESOLVES**, as it hereby **RESOLVED**, to **GRANT** CPD credit units to all professional providing essential services during the period of the State of Public Health Emergency throughout the Philippines, until it is lifted, subject to the following provisions:

1) Professionals providing essential services during this period shall earn the following CPD credit units:

DESCRIPTION	Maximum CPD Credit Units that may be Granted
Health and Emergency Frontliners that provided public health services (all employees of the Department of Health (DOH), DOH Hospitals, Hospitals of LGUs and Provincial, City, and Rural Health Units, and Drug Abuse Treatment and Rehabilitation Centers including those managed by other government agencies (e.g. police and military hospitals/clinics, university medical facilities), uniformed medical personnel], private health workers, such as but not limited to medical professionals, hospital and health facility administrative and maintenance staff, and aides from private health facilities, as well as their service providers, health workers and volunteers of the Philippine Red Cross and the World Health Organization, and the employees of Health Maintenance Organizations (HMOs), the Philippines Health Insurance Corporation (PHIC), disaster risk reduction management officers, and public safety officers. Researchers and scientists who developed testing kits,	45
professionals who designed/constructed accommodations for suspected, probable and confirmed COVID-19 patients and health care workers, disinfection chambers and adapted medical equipment such as ventilators and aerosol boxes.	
Vital Goods and Services Providers who provided health and social services to secure the safety and well-being of persons, such as but not limited to, food, water, medicine, medical devices, public utilities, energy and others as may be determined by the IATF. <sup>2</sup>	
Volunteer professionals who offered services during this COVID – 19 crisis, including but not limited to, answering queries about COVID-19, online consultation, public health education and other activities directly related to their profession.	25

Volunteer professionals who responded and participated in Social Responsibility (CSR) programs / projects, whether in their personal capacity or through organizations, collected, packed and distributed medical supplies and masks or personal protective equipment (PPE) to hospitals/ medical facilities, and distributed food to frontliners serving in hospitals/medical facilities and security check points.

- 2) As proof of the services rendered, all covered professionals shall submit either a Certification from Institution/Agency/Entity (Annex "A") or own Declaration (Annex "B"), as may be applicable.
- 3) Professionals can only use this activity for the Professional Identification Card (PIC) renewal by applying the same under Self-Directed Learning (SDL) modality. However for this purpose the prescribed fee is deemed waived. Credit units earned may be used for two (2) consecutive renewal cycles.
- 4) Professionals, on the appointed date of the release of PIC, shall proceed to the venue chosen to claim it. Upon presentation of the above stated documents and the other requirements for renewal, their PICs shall be released.
- The SDL applications shall be subject to evaluation by the concerned CPD Council within fifteen (15) working days from receipt. The Council may request for additional supporting documents from the applicant if deemed warranted.
- The CPD Councils shall issue their respective advisories to assist and guide the applicants on the award of CPD credit units.
- Professionals who opt to apply the said CPD activities for consideration under the Career Progression and Specialization Program, shall submit the learning outcomes thereof to the concerned CPD Council for evaluation and recognition. The CPD Council may consider the learning outcomes derived from professional experiences during the COVID-19 crisis as part of the requirements for the said program.
