3. Immediate and wide dissemination of this Memorandum is desired.

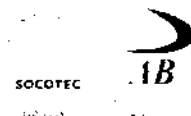

This has reference to the 1st Department of Education (DepEd) and the Ministry of Basic, Higher and Technical Education - Bangsamoro Autonomous Region in Muslim Mindanao (MBHTE-BARMM) Convergence Meeting that was held on February 19, 2021 as an initiative to establish a better collaboration in addressing important matters related to the delivery of quality and accessible education services and the improvement of an inclusive education system in the BARMM. This was followed by the 2nd DepEd - MBHTE-BARMM Convergence Meeting on June 11, 2021.

A **core group** composed of EXECOM Representatives, counterparts, and staff focals from DepEd Central Office (CO) and the MBHTE-BARMM teams was established to manage and facilitate meetings supported by the secretariat. It was agreed that quarterly meetings will be conducted between the DepEd CO and the BARMM, but additional meetings can be convened if and when there are urgent concerns that need to be discussed. The DepEd CO team will also include resource persons depending on the particular topic(s) needed to be discussed and agreements needed to be deliberated over. Internal Meetings were also set in which thematic areas for discussion included matters on nationally-funded programs and the allocation of teaching positions in the BARMM.

This is to respectfully transmit the Minutes of the 1st and 2nd DepEd-MBHTE Convergence Meetings to Your Office, the designated in-charge of matters related to the operationalization of the DepEd's commitments to the BARMM, which is stated in the attached OO-OSEC-2021-030 dated August 2, 2021. Also attached herewith is the memorandum on the final core group focals from the DepEd Central Office and the MBHTE-BARMM for your reference.

We will also schedule a briefing with Your Office as soon as we get the schedule of availability of former Undersecretary Jesus L.R. Mateo.
