CONDUCT OF VIRTUAL ORIENTATION ON THE PREPARATION OF FY

2022 BUDGET EXECUTION DOCUMENTS (BEDs)

- 1. The Department of Budget and Management recently released the National Expenditure Program for FY 2022 of all implementing and non-implementing units. Per Department of Budget of Management Circular Letter (DBM-CL) 2019-13, all departments/agencies/operating units (OUs) are annually required to submit their respective Budget Execution Documents (BEDs) to serve as bases for the formulation of the national government's budget release schedule.
- 2. In this view, all schools are enjoined to discuss with their respective School Planning Team and initially design its programs, activities and projects for FY 2022 that will serve as a tool in preparing the Budget Execution Documents which will be submitted on October 28, 2021.
- 3. Further, there will be a virtual orientation on the Preparation of FY 2022 Budget Execution Documents (BEDS) via MS Teams on **October 19, 2021 at exactly 8:00 a.m.** This activity aims to equip the participants with the technical knowledge in preparing:
  - a) Quarterly School Operating Budget for FY 2022;
  - b) Monthly School Cash Program for FY 2022, and;
  - c) Annual Procurement Plan for Common-Use Supplies and Equipment for FY 2022.
- 4. The participants of the orientation are the following:
  - a. Elementary and Secondary School Heads (non-IUs)
  - b. Administrative Assistant II in schools (non-IUs)
  - c. Administrative Assistant III in schools (non-IUs)
  - d. School Property Custodian/In-charge in preparing APP-CSE
