Subject: YEAR-END TAX ADJUSTMENT FOR CY 2021

- 1. In order to ensure that the employees' total tax withheld for the taxable year 2021 is equal to the total tax due, tax adjustments shall be made against employees' salaries for the period October to December, 2021.
