## POLICY GUIDELINES ON THE PUBLICATION AT THE DEPED MALAYBALAY WEBSITE

- 1. The publication is open to all DepEd Employees both teaching and non-teaching personnel of the Division of Malaybalay City.
- Educational articles written in English and Filipino will be accepted in the publication.Literary articles such as songs/poems/compositions are not allowed.
- 3. Writers/Contributors must use an article submission form in Microsoft word format with font size 12 and Arial font style.
- 4. All articles shall undergo screening and editing by the Division Screening Committee.
- 5. Articles may be written in first or third person point of view (POV).
- 6. Content words should not be less than 2000 words and should not exceed 5000 words
- 7. Seventy percent (70%) of the article must be originally written by the author, has not been published in other publication sites and must pass the plagiarism test and grammar test. If references are used, proper citation is required.
- 8. Articles submitted must not be subversive nor will be in violation of any existing rules and regulations of the agency and must not attack any person or entity.
- 9. Images attached to the article must be original action pictures or *free to use* images from a public domain site using *jpeg* format (Optional).
- 10. All submission that are non-compliant on the above stipulated policy guidelines shall not be considered for publication and will not qualify to be posted in the website.
