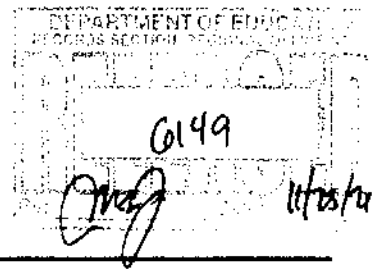

**SCHEDULE OF TRAINING ENHANCEMENT
FOR DIVISIONAL DEPED TV TEAMS**

To: Schools Division Superintendents
All Others Concerned

1. As regards Regional Memorandum No. 676, s. 2021 re Training Enhancement for Divisional DepEd TV Teams, the activity will be conducted on January 17-21, 2022 due to earlier schedules already set.

2. At the end of the activity, the participants are expected to achieve the following:

- a. Master the basics of operating video field equipment including camera, audio, and lighting;
- b. Use digital editing and multiple video elements together (images, sound, interviews, music, etc.) to achieve learning objectives in a lesson;
- c. Feel confident in the basics of creating and overseeing a field production such as pre-production, production, direction, and post-production; and
- d. Empower the teachers in the delivery of instruction in front of the camera.

3. The expected participants from all Schools Division Offices (SDOs) will be a core team of five members with the following qualifications:

- a. Four members must be DepEd teaching or nonteaching personnel with background and skills in any of the following: media arts, videography, photography, video editing, directing and writing; and
- b. One DepEd teacher-broadcaster who has pleasing personality and excellent oral and written communication skills

TRAINING ENHANCEMENT FOR DIVISIONAL DEPED TV TEAMS

To: Schools Division Superintendents
All Others Concerned

1. Inspired by the DepEd TV awards received from the Central Office (CO), this Office finds it essential to conduct a training enhancement to replicate the best practices of the Division of Lanao del Norte in the development of distance learning resources, specifically Television-Based Instruction (TBI) learning resources for national, regional, and divisional levels.
2. The training enhancement will be conducted in five days, in-house and face-to-face upon the approval of the IATF to be held at the National Educators Academy of the Philippines (NEAP), Regional Education Learning Center (RELC), Lapasan, Cagayan de Oro City. The schedule of the activity will be announced in a separate issuance.
3. All divisions, except Division of Lanao del Norte, are advised to send five participants who will compose the DepEd TV Core Team. DepEd CO will be the training team, along with the Technical Working Group from the Curriculum and Learning Management Division (CLMD).
4. The participants and all others who are involved in the activity shall undergo Rapid Antigen Test and strictly stay inside the venue throughout the duration of the training.
5. Expenses incurred shall be charged to Regional Office (RO) funds while transportation expenses of divisional participants shall be charged against local funds or any other source of funds, subject to the usual accounting and auditing rules and procedures.
