AN ORDER AMENDING CERTAIN PROVISIONS EXECUTIVE ORDER NO. 160, s. 2021, PRESCRIBING THE COMMUNITY QUARANTINE PROTOCOLS AND GUIDELINES IN THE CITY OF MALAYBALAY WHILE UNDER COVID-19 ALERT LEVEL 2 CLASSIFICATION

Whereas, on December 16, 2021, the Malaybalay City Emergency Operations Center (EOC) for COVID-19 has recommended for the amendments of some provisions of Executive Order No. 160, s. 2021, in view of the decreasing number of COVID-19 infections in the City of Malaybalay and also to jump-start the recovery of some businesses affected by the pandemic;

Whereas, the said recommendations to be supported by data from the City Health Office and from the Malaybalay City Disaster Risk Reduction and Management Office;

NOW THEREFORE, I, **FLORENCIO T. FLORES, JR.**, City Mayor of the City of Malaybalay, Bukidnon, by the power vested in me by law, do hereby ORDER the amend certain provisions of EO No. 160, s. 2021, as follows:

1. Item No. 2 of the said EO No. 160, s. 2021 is amended to read as follows –

"2. Movement of all persons shall now be allowed outside of their residences, provided that minimum public health standards are at all times observed by the residents and visitors. Provided, further, that children eleven (11) years and below shall be accompanied at all times by guardians or parents when entering establishments and going to crowded places;"

2. Item No. 6 is hereby amended to read as follows –

"6. Curfew Hours – Imposition of curfew hours from 12:00 mid-night to 3:30 in the morning the next day, except for emergency cases, frontliners (medical and non-medical persons) going to and from their place of work, transients passing through Malaybalay City and returning residents (from outside Malaybalay City);

This Order shall take effect immediately until sooner revoked or amended.
