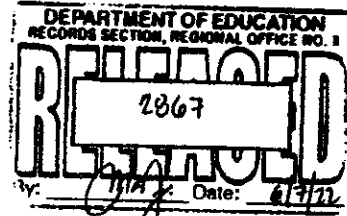

Greetings from the Philippine Commission on Women (PCW)!

PCW's National GAD Resource Program's (NGRP) vision to create an accessible, innovative and informative platform to increase awareness and knowledge of policymakers, public officers and gender trainers on gender and development mainstreaming supports the conduct of the 2022 GAD Webinar Series. Through this, PCW strategically addresses the demand for technical assistance (TA) of the requesting government agencies. This is also an alternative modality to the conduct of face-to-face TA as a way to observe health protocols during the COVID-19 pandemic.

As our partner in gender mainstreaming at the regional and local levels, we are pleased to invite the member agencies of Regional GAD Committees (RGADCs) to the fourth GAD Webinar for 2022 of PCW, titled, "In-Depth Orientation on Gender Mainstreaming and Evaluation Framework (GMEF)", scheduled on 23 June 2022, from 8:20 AM to 4:40 PM. This learning session aims to influence public servants to support gender equality and women's empowerment by discussing Gender Mainstreaming and Evaluation Framework (GMEF) as a crucial element in gender mainstreaming. It also intends to enhance appreciation of participants on GMEF as a tool to measure the extent of gender mainstreaming efforts of organizations, both in National Government Agencies (NGAs) and Local Government Units (LGUs).
