

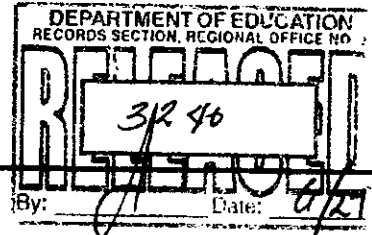

GSP EMR REGIONAL TRAINING SCHOOL 2022


