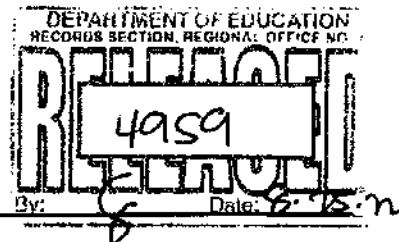





1. Section 7(8), Chapter 2, Book IV, Executive Order No. 292 titled **Instituting the Administrative Code of 1987** provides that the Secretary has the power and function to delegate the authority to officers and employees under his or her direction in accordance with this code.
2. Pursuant thereto, effective 18 July 2022, **EPIMACO V. DENSING III**, Undersecretary and Chief of Staff, shall have the authority to sign the approval of authorities for travels abroad for personal vacation leave and official business/time, including the heads from the attached agencies.
3. The delegation of the function herein provided shall not preclude the Secretary from signing said personnel documents, if necessary, in the interest of the service.
4. This Order shall remain effective until rescinded or revised.
