**AN EXECUTIVE ORDER RECONSTITUTING THE MALAYBALAY CITY
PRICE COORDINATING COUNCIL (MCPC)**

WHEREAS, Republic Act No. 7394, otherwise known as the Consumer Act of the Philippines, states that the state shall protect the interests of the consumer against hazards to health and safety and against deceptive, unfair and unconscionable sales, acts and practices; promotes his general welfare; and establish standards of conduct for business and industry;

WHEREAS, Republic Act No. 7581, as amended by R.A. 10623, otherwise known as the "Price Act" embodies the policy of the state to ensure the availability of basic necessities and prime commodities at reasonable prices at all times without denying legitimate business a fair return on investment, as well as the policy to provide effective and sufficient protection to consumers against hoarding, profiteering and cartels with respect to the supply, distribution, marketing and pricing of said goods, especially during periods of calamity, emergency, widespread illegal price manipulation and other similar situations;

WHEREAS, there is a need for the Implementing Agencies under the Price Act to work closely with the LPCCs and to harmonize the monitoring of supply and prices in compliance with Automatic Price Control or Price Freeze, or mandated price ceiling, if any, during a declared state of calamity or emergency;

NOW THEREFORE, I, **JAY WARREN R. PABILLARAN**, Mayor of the City of Malaybalay, by the power vested in me by law, do hereby order the reorganization of the Malaybalay City Price Coordinating Council, to wit:

Section II. FUNCTION. The MCPCC shall carry out its powers and functions as embodied under R.A. 7581 (Price Act) as amended under R.A. 10623 and other pertinent rules and issuances of the Department of Trade and Industry to achieve the objectives stated therein.

Section III. PROVINCIAL PRICE MONITORING TEAM. There shall be a City Price Monitoring Team composed of DTI-Bukidnon, City Health Office, and the City Agriculture Office representatives, for the purpose of monitoring the prices and supply of basic necessities and prime commodities.

Section IV. MEETING AND QUORUM. The MCPCC shall meet at least once every quarter or as often as may be necessary. Majority of all the members present shall constitute quorum to do business.

Section V. SECRETARIAT. The City Planning and Development Office shall provide secretariat to the Council and shall be responsible for providing for technical support, documentation of proceedings and activities, preparation of reports and such other assistance as may be required by the Council.

Section VI. FUNDING. The City Government of Malaybalay shall source its funds from the discretionary funds of the City Mayor's Office to defray the cost of meetings, communication, networking and monitoring activities.

This Order shall take effect immediately.
