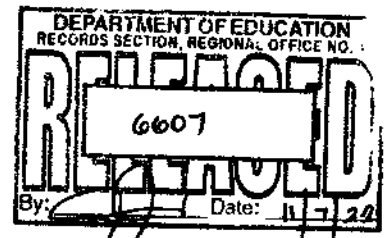

- **TEC Caravan (Mindanao Cluster) - November 17-18, 2022**

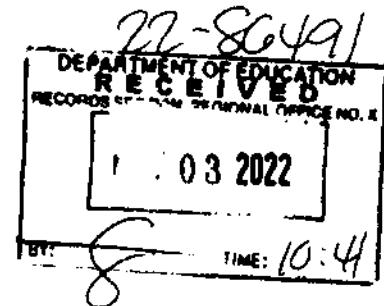
