AN ORDER DEPUTIZING MEMBERS OF THE PHILIPPINE WIDE ANTI-SMOKING OPERATION FOR HEALTH ENFORCERS OF MALAYBALAY CITY

WHEREAS, the 1987 Philippine Constitution declares that the state shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 24 of Republic Act 8749 also known as the "Philippine Clean Air Act of 1999", mandates the local government units to implement the prohibition of smoking inside a public building or an enclosed public place including public vehicles and other means of transport or in any enclosed area outside of one's private residence, private place of work or any duly designated smoking area;

WHEREAS, City Ordinance No. 885 series of 2017 "An Ordinance Revising the Smoke-Free Ordinance of the City of Malaybalay", section 16 second paragraph reads: The Mayor may deputize qualified civilians to also serve as enforcers of this Ordinance. Any person can file with the Task Force a report or a complaint, or present evidence for any violation of this Ordinance, or be assigned other duties pursuant to the attainment of its effective implementation;

NOW THEREFORE, I, JAY WARREN R. PABILLARAN, City Mayor of Malaybalay City, Bukidnon, by the power vested in me by law, do hereby deputize the following members of the Philippine Wide Anti-Smoking Operation for Health (PWASOH) as enforcers and may apprehend individuals caught in violation of Section 5 of the Malaybalay City Ordinance No. 885, to wit:
