CREATING THE TASK FORCE "PAPUTOK" 2022

WHEREAS, Section 16 of the Local Government Code mandates that Local Government Units (LGUs) shall promote the health and safety of their constituents;

WHEREAS, various types of fireworks and firecrackers flood the market during Holiday Seasons, particularly on Christmas and New Year's Eve.

NOW THEREFORE, I, JAY WARREN R. PABILLARAN, City Mayor of Malaybalay City, Bukidnon, by virtue of the powers vested in me by law, do hereby order the creation of Task Force "Paputok" 2022, to wit:

SECTION 1. COMPOSITION:

SECTION 2. FUNCTIONS. The Task Force shall:

1. Cause the inspection of quantities and kinds of firecrackers and pyrotechnic devices sold and stock by the retailers or distributors;
2. Strictly enforce the provisions of Republic Act. No. 7183 or the law regulating the manufacture and sale of firecrackers and pyrotechnics, and ensure that all banned products as classified and declared by the Department of Health, the Department of Trade and Industry and other regulatory agencies will not be sold in the market;
3. Closely coordinate with firecrackers and pyrotechnics distributors and/ or retailers to prevent any untoward incident such as fires and explosions in their stores and most importantly, to reduce firecracker related deaths and injuries;
4. Ensure that only those with special business permits may sell and distribute pyrotechnic products in the City;
5. Implement aggressive campaign against smuggled firecrackers and pyrotechnic products by going after unscrupulous traders and distributors;
6. Cause the confiscation and disposal of firecrackers and pyrotechnic devices being sold illegally;
7. Cause the prosecution of violators of existing national laws, rules and regulations, and ordinances on manufacture, sale, and distribution firecrackers and pyrotechnics; and
8. Perform other functions incidental to the proper implementation of this Executive Order.

SECTION 3. DESIGNATED DISPLAY AREA. The designated display area for the selling of firecrackers and pyrotechnic devices shall be at Barangay 6 (near Red Cross Building), this City.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately.
