**SUBMISSION OF GENDER AND DEVELOPMENT (GAD)  
ACCOMPLISHMENT REPORTS (AR) 2021**

To: Schools Division Superintendents  
All Others Concerned

1. Regarding the Region's implementation of the Gender and Development (GAD) program, the deadline for the submission of the GAD Accomplishment Reports CY 2022 is **December 29**.
2. In preparing the reports, please consider the following:
  - a. The unified gender issues and mandates shall be observed for easy consolidation. (Refer to Gender Issues and Mandates posted in the GC).
  - b. Use the standard template. Harmonized Gender and Development Guidelines (HGDG) computations shall be done if there is an attribution of expenditures. (Refer to PCW MC NO. 2021 - 06).
  - c. The soft copy of the accomplishment reports shall be in EXCEL format, not scanned, and be uploaded to the google drive link to be provided later.
  - d. There shall only be one consolidated accomplishment report for every division. Do not separate the accomplishment report of the schools and the independent unit schools; integrate them all.
  - e. Submission of the hard copy of the AR to the Regional Office (RO) through the Human Resource Development Division (HRDD) shall be on or before January 17.
3. This Office directs the immediate and wide dissemination of this Memorandum.
