





AN EXECUTIVE ORDER CREATING THE WATER SAFETY BOARD OF THE CITY GOVERNMENT OF MALAYBALAY AND PROVIDING FOR ITS TECHNICAL WORKING GROUP

WHEREAS, Department of Health (DOH) Administrative Order 0027 Series of 2014 mandates for the formulation of the Water Safety Plan (WSP) for all drinking water service providers;

WHEREAS, there is a need to create the Water Safety Board to ensure that the City of Malaybalay being the bulk provider for drinking water shall comply with the provisions of DOH Admin. Order 2014-0027 and compliant to the applicable implementing rules and regulations (IRR) of the Sanitation Code of the Philippines (PD 856) to ensure the safety of the drinking water offered to the constituents of the City of Malaybalay;

WHEREAS, it is necessary to organize a board to specifically work on the formulation of the Water Safety Plan to establish a comprehensive risk assessment and risk management approach that encompasses all steps in water supply from catchment to consumer to consistently ensure the safety of drinking water;

NOW THEREFORE, I JAY WARREN R. PABILLARAN, City Mayor of the City of Malaybalay by powers vested in me by law, do hereby order the creation of board for the enactment of the Water Safety Plan Board, viz:

Section 1. Composition of the Water Safety Plan Board - Which shall spearhead the formulation of the Water Safety Plan for the City of Malaybalay and shall be composed of:

Section 2. Composition of the Water Safety Plan (WSP) Technical Working Group (TWG).

Section 3. Duties and Responsibilities. The Water Safety Board shall perform the following functions:

- A. Conceptualize framework from the inception until after the finalization/submission of the Water Safety Plan for the City of Malaybalay;
- B. Formulate and adopt specific and related rules, regulations and guidelines pertaining to the Water Safety Plan;
- C. Develop plans, solicits suggestions, programs and strategies beneficial to the City to ensure the providence of safe drinking water supply for the City of Malaybalay;
- D. Serves as the advisory body of the Local Chief Executive and the Sangguniang Panlungsod on all matters affecting the management, operation, expansion, improvement, and the administration of the Water Safety Plan for the City of Malaybalay.

Section 4. Secretariat. The City Economic Enterprise Development Management Office shall serve as the Board Secretariat.

Section 5. Automatic Assumption. Should any member of the Board cease to hold his/her office by reason of permanent incapacity, removal, resignation or the likes, the person who succeeded or is appointed in that particular office/ position shall automatically become a member hereof. Re-assumption of office by incumbent officials of their original office shall also operate as automatic assumption of the membership of the board.

Section 6. Effectivity. This order shall be effective immediately.
