SUBJECT: **DISSEMINATION OF EXECUTIVE ORDER NO. 17 Series of 2023 (AN ORDER ADJUSTING THE TIME FOR TRUCK BAN/ RE-ROUTING SCHEME WITHIN THE POBLACION OF MALAYBALAY CITY AND TEMPORARILY REGULATING THE TURNINGS OF MOTOR VEHICLES PLYING ALONG THE NATID-ASAN ROAD, PUROK 5, BARANGAY 9, THIS CITY)**

**AN ORDER ADJUSTING THE TIME FOR TRUCK BAN/ RE-ROUTING SCHEME WITHIN THE POBLACION OF MALAYBALAY CITY AND REGULATING THE TURNINGS OF MOTOR VEHICLES PLYING ALONG THE NATID-ASAN ROAD, PUROK 5, BARANGAY 9, THIS CITY**

**WHEREAS**, the present traffic regulation of the City Government of Malaybalay provides a cargo truck ban and rerouting scheme which prohibits cargo trucks and vans from using the national highway (from Brgy. Sumpong [DepEd Compound] to Brgy. Casisang [Welcome Arch] and vice vice) from 6:00 a.m. to 8:00 p.m. daily;

**WHEREAS**, there has been a substantial increase in pedestrian and vehicle volume in the City Proper during peak hours (as early as 5 in the morning and 8 in the evening), especially among the student populace who are having an early morning classes starting at 6:00 a.m.

**WHEREAS**, in addition to the above-mentioned, the Traffic Management Center (TMC) also noted the worsening traffic conditions which cause vehicular traffic accidents at Natid-asan Road, Purok 5, Barangay 9, this City;

**WHEREAS**, to forestall any accidents and injuries among the pedestrians, especially students from local educational institutions and small motor vehicles which may be caused by large cargo trucks and vans, the Traffic Management Center has recommended for the adjustment of truck ban and rerouting scheme to start at 5:00 in the morning;

**WHEREAS**, to alleviate the present traffic conditions at Natid-asan Road, the TMC likewise recommended for a temporary designation on the the turnings of motor vehicles plying along the mentioned road;

**NOW, THEREFORE I, JAY WARREN R. PABILLARAN**, Mayor of the City of Malaybalay, by virtue of the powers vested in me by laws, do hereby order the following:

**SECTION 1. ADJUSTMENT OF TIME FOR CARGO/ DELIVERY TRUCK BAN/ RE-ROUTING SCHEME.** Cargo/delivery trucks, are prohibited from using the national highway (north and south bound lanes) from Barangay Sumpong (before DepED Compound) to Barangay Casisang (Welcome Arch) for the time period of **5:00 a.m. to 8:00 p.m. daily.**

These vehicles shall use the Barangay Sumpong – Barangay Casisang diversion/ by-pass road, passing through Barangay 11, this City.

**SECTION 2. TEMPORARY REGULATION ON THE TURNING OF MOTOR PLYING NATID-ASAN ROAD** The turning of motor vehicles plying along Natid-asan Road are hereby regulated for public safety, as follows:

- a. The ingress for all southbound vehicles from Fortich St./ National Highway or Pabillaran St. going towards Purok 5, Barangay 9 or Natid-asan, Barangay Casisng shall be the Natid-asan Road junction Fortich St./ Sayre Highway (fronting Shell Gasoline Station); and
- b. The egress for all northbound vehicles from Purok 5, Barangay 9 or Natid-asan, Barangay Casisang towards National Highway shall be the Natid-asan Road junction Pabillaran St.(fronting Belsar Enterprises);

**SECTION 3. REPEALING CLAUSE.** All other orders or parts thereof which are inconsistent with the provisions of this Order hereby repealed or modified accordingly.

Issued this 20th of February 2023 in Malaybalay City, Bukidnon.

This Order shall take effect immediately.
