The scholarship is open to graduating Grade 12 students who shall take any of the following courses:

Agriculture	Agronomy, Crop Science, Horticulture
Engineering	Agricultural, Electrical, Industrial, Mechanical, Electronics
Finance	Accountancy

QUALIFICATION OF APPLICANTS

- 1. Incoming first year college student by start of school year 2023-24
- 2. Must have an average grade of at least 90% in the 1st and 2nd grading periods of the current school year as certified and recommended by the school principal
- 3. A permanent resident of municipalities or cities in Bukidnon or Misamis Oriental where DMPI operates
- 4. Must apply online at https://forms.gle/Del Monte Foundation Academic College Scholarship Application 2023. Or, they can check out the Del Monte Foundation page on Facebook for the link to the online form. Cut-off for accepting applications is on March 11, 2023.
- 5. Physically fit for schooling and of good moral character
- 6. Must take & pass the DMFI scholarship qualifying exam and final screening
- 7. Must pay the testing fee on the exam day which will be scheduled in April.

SCHOLARSHIP COVERAGE

School fees

Uniform allowance per year - Php2,000

Book allowance per semester - Php3,000

Living allowance per month – Php5,000

Airfare allowance per school year -1 round-trip ticket from home province to school location for those who will study outside Mindanao

- Those who pass the qualifying exam shall be required to submit the following documents to qualify for the final interview:
 - a. Most recent 2x2 ID picture
 - b. Copy of parents' proof of income (any of the following: CY 2021 income tax return, DSWD certification of low income, BIR proof of tax exemption or recent pay slip for at least 2 months)
