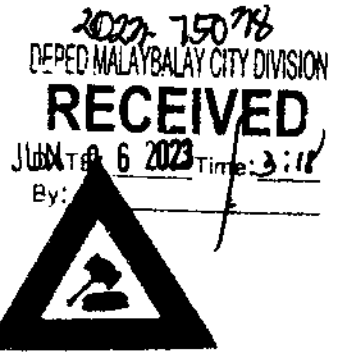

WHEREAS, it is the responsibility of the state to nurture and protect the interest of the youth. The state must see to it that the youth rightfully receive quality education, in order for them to grow intelligent, conscientious, civic-minded individuals who will be foundational to the nation's future. Crucially, this education must be delivered through institutions that encourage social awareness and critical thinking students. The Filipino youth is a thinking youth, and the state must ensure that educational institutions will encourage that, and not suppress it;

WHEREAS, pursuant to Article II, Section 15 of the 1987 Philippine Constitution, it is hereby declared the policy of the State to protect and promote the right to health of the people and instill health consciousness among them. In line with this policy, the State shall endeavor to promote every Filipino's full potential through good vision by creating ways and means to address vision problems, including blindness, among children;

WHEREAS, R.A 11358 also known as "AN ACT ESTABLISHING A NATIONAL VISION SCREENING PROGRAM FOR KINDERGARTEN PUPILS AND APPROPRIATING FUNDS THEREOF" states that the state shall institute a program that will help screen the school children with visual problems;

WHEREAS, eyesight problems are prevalent among students especially in the elementary; students with eyesight problems will most likely to have slipping grades, difficulty in understanding the lessons and might as well loose interest in attending school;

WHEREAS, it is imperative to determine and identify students with eyesight problems in order to address and resolve it with appropriate tools and medication and shall not hinder the studies of the students;

WHEREFORE, on motion of Board Member Ranulfo Jose Jr. Z. Pepito, and unanimously seconded by all Sangguniang Panlalawigan Members present, assembled in session:

BE IT RESOLVED, as it is hereby resolved, RESPECTFULLY REQUESTING THE SCHOOLS DIVISION SUPERINTENDENTS OF THE THREE DIVISION OF THE DEPARTMENT OF EDUCATION IN THE PROVINCE OF BUKIDNON TO CONDUCT MANDATORY EYE SCREENING AND EXAMINATION FOR ELEMENTARY STUDENTS AS PART OF THE REQUIREMENTS FOR ENROLLMENT TO IDENTIFY STUDENTS WITH EYESIGHT PROBLEMS AND BE TREATED WITH APPROPRIATE INTERVENTION AND/OR MEDICATION.
