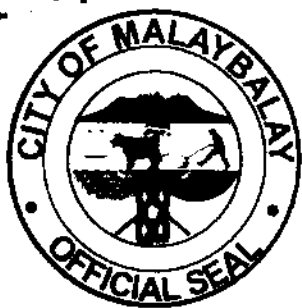

**AN EXECUTIVE ORDER DESIGNATING NATID-ASAN ROAD,
POBLACION BARANGAY 9 AS A NO-PARKING ZONE**

WHEREAS, the Natid-asan Road, Brgy. 9, this City was temporarily designated as one side parking zone pursuant to City Ordinance No. 961, s. 2020;

WHEREAS, the Traffic Management Center (TMC) of the City Government of Malaybalay has recommended for the suspension of the implementation of City Ordinance No. 961, s. 2020, in view of traffic congestion posed by parked vehicles along the said road;

WHEREAS, further, the TMC also noted that the present traffic scheme is obstructing emergency vehicles (ambulances, fire trucks and PNP vehicles) responding to accidents and emergency situations at the Natid-asan area;

WHEREAS, City Ordinance No. 900, s. 2019, particularly Section 40 thereof, authorizes the City Mayor upon recommendation of the Traffic Management Center, to designate No Parking Zones within public roads and streets of the City of Malaybalay;

NOW THEREFORE, I, JAY WARREN R. PABILLARAN, City Mayor of Malaybalay City, by virtue of the powers vested in me by law do hereby order the following:

Section 1. Designating the Natid-asan Road from junction Sayre Highway to San Victores St.; Natid-asan Road (across the Polymedic General Hospital) until Kalawaig Bridge; and Kalawaig Bridge to relocation site junction of Sitio Natid-asan, as No Parking Zone

Section 2. The Traffic Management Center shall implement this Order after One (1) week of information dissemination to the affected residents. Proper signages shall be installed at strategic places at the area.

Section 3. Let a copy of this Order be furnished to the Sangguniang Panlungsod Malaybalay City pursuant to Section 10 of City Ordinance No. 900, s. 2019.
