## SUBJECT: YEAR-END ADJUSTMENT FOR CY 2023

- 1. In order to ensure that the employees' total tax withheld for the taxable year 2023 is equal to the total tax due, tax adjustments shall be made against employees' salaries for the period September to December 2023.
- 2. Employees' compensation is annualized in order to determine each employee's amount of tax due for the year which is derived as follows:
