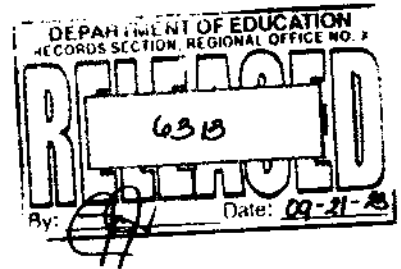

EMPLOYEE REGISTRATION TO PHILHEALTH KONSULTA

1. This is to disseminate to the field Memorandum DM-OUHROD-2023-1268 re: *Employee Registration to PhilHealth Konsulta*. To expedite the registration and availment of PhilHealth Konsulta Benefits for all DepEd employees, the Regional Office and the Schools Division Offices shall facilitate the PhilHealth Konsulta registration process through either of the following:

- a. Self-registration by teachers/employees through the PhilHealth Member portal (); or
- b. RO (for the RO employees) and SDOs (for the SDO employees and Schools teaching and nonteaching personnel) shall directly coordinate and submit the PhilHealth registration form to its local PhilHealth office.

2. All employees must be registered to PhilHealth Konsulta on or before **October 31, 2023**. This is to ensure that all employees may already avail the Konsulta benefits, including the Annual Physical Examination, the soonest possible time.

3. This Office strictly observes the Equal Opportunity Policy (EOP) in all steps to be undertaken for this purpose. Hence, all decisions and actions shall be based solely on guidelines set forth, with no discrimination on the account of age, gender identity, sexual orientation, civil status, disability, religion, ethnicity, or political affiliation.

4. Immediate dissemination and strict compliance of this Memorandum is enjoined.
