

DELIVERY UNITS FOR THE FY 2022 PERFORMANCE-BASED BONUS

- This is in reference to the grant of the Performance-Based Bonus (PBB) for FY 2022. The Department of Education (DepEd) Region 10 is requiring the submission of performance ranking reports (Form 1.0) of all its delivery units and personnel pending the release of the agency eligibility results from the AO 25 Inter-Agency Task Force (IATF).
- In February 2022, the Department issued the DepEd Order 005 s. 2022, entitled Performance-Based Bonus Guidelines on Eligibility Requirements and Accountability Matrix. to provide guidance on the PBB Guidelines, including the new prescribed: (a) eligibility requirements, and (b) accountability matrix on the grant of PBB starting Fiscal Year 2021 and the succeeding years.
- To provide time to the Division Office Performance Management Team (DO PMT) to consolidate the required Division Report, the Schools are directed to submit to this office the soft copy and signed scan copy of School Personnel Data Form 1.0 template on or before October 24, 2023 at ehrismalaybalay@gmail.com.
