Dear Schools Division Superintendent Reyes,

This is to respectfully seek the assistance of your good office in relation to the hosting of Malaybalay City with the **Bagong Pilipinas Serbisyo Fair (BPSF)** on **November 11-12, 2023**. In line with this, we are requesting that DepEd – Malaybalay City formally require **Bukidnon National High School** to temporarily implement blended learning modalities on November 9 – 10, 2023.

The safety of students and their continuous learning should be of primary concern, considering that there will be various government agencies and local offices who will conduct final preparations of their services and logistical requirements around the venues of the BPSF. For your information, estimated attendance for BPSF-Bukidnon is approximately 80,000 beneficiaries and 48 government agencies.
