



REQUEST OF THE RELIGIOUS GROUPS TO CONDUCT VALUES EDUCATION TEACHING TO SCHOOLS IN DEPED REGION X

To: Schools Division Superintendents
Assistant Schools Division Superintendents
All Others Concerned

- 1. The 1987 Philippine Constitution provides optional religious instructions for the learners at the option expressed in writing by the parents, or guardians, and without additional cost to the government (Section 3, Article XIV).
- 2. The Department of Education's (DepEd) K to 12 Curriculum and the upcoming MATATAG Curriculum provide both learners and teachers with full learning and teaching loads, respectively. Accommodating additional learning and teaching load may put the learners and teachers in exhaustion.
- 3. The Office has received requests from different religious denominations to conduct school-based activities for school leaders, teachers, and learners. All requests from any religious denominations must be coordinated and submitted directly to the concerned Schools Division Offices (SDOs).
- 4. The Schools Division Superintendents (SDSs) are given the discretion to decide on any requests from any religious groups but must ensure the following:
 - a. No learning area from the K to 12 Curriculum and the upcoming MATATAG Curriculum shall be compromised;
 - b. No teacher nor school leader shall be involved in any activity of the religious group;
 - c. No learner shall be forced. Participation must be VOLUNTARY in nature;
