



REGIONAL RETOOLING OF NEW SCHOOL HEADS OF INDIGENOUS PEOPLES EDUCATION (IPED) IMPLEMENTING SCHOOLS

To: Schools Division Superintendents Assistant Schools Division Superintendents All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD), announces the **Regional Retooling of New School Heads of Indigenous Peoples Education (IPED) Implementing Schools at New Dawn Hotel, Cagayan de Oro City, on April 16-19.**

- 2. The activity aims to
 - a. orient the new school heads and update them on the different DepEd orders related to the implementation of Indigenous Peoples Education (IPED);
 - b. equip them with competencies that will help them effectively supervise their teachers in delivering EPED lessons; and
 - c. develop among them the value of appreciating Indigenous Knowledge Systems and Practices (IKSPs).

3. The participants in this activity are the regional and divisional focal persons, together with the identified schools heads. Please check the attachment for the required number of participants per division.

4. The participants are required to arrive at the venue on April 16 (Tuesday) with breakfast as the first meal. Departure will be on April 19 (Friday) with dinner as the last meal.

5. The participants shall pay the registration fee of P2,000.00/day for the accommodation, meals, and snacks. There will be a pre-work for the program management holders/facilitators and IPED focal persons at the LRMDS, DepEd Regional Office X, Zone 1, Upper Balulang, Cagayan de Oro City, on April 15. Board and lodging for the prework shall be charged to the divisions' IPSF/MOOE, subject to the usual accounting and auditing rules and regulations.
