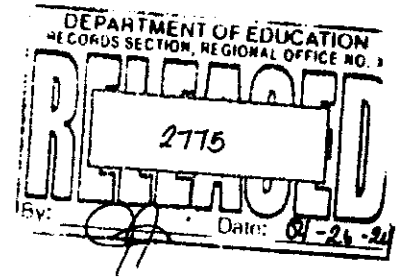

REGIONAL SCREENING AND ACCREDITATION COMMITTEE ACTIVITIES  
FOR THE 2024 NORTHERN MINDANAO REGIONAL  
ATHLETIC ASSOCIATION (2024 NMRAA) MEET

To: Schools Division Superintendents  
All Others Concerned

1. The Regional Screening and Accreditation Committee (RSAC) will continue the screening activities and begin their accreditation activities in Camiguin, on May 11-15.
2. The committee will conduct an actual field monitoring on the first day of the 2024 Northern Mindanao Regional Athletic Association (2024 NMRAA) to inspect the actual athletes fielded by the coaches and chaperons.
3. Unjustified refusal on the part of the coaches or chaperons to subject their athletes to inspection shall create the presumption that the fielded athletes are not the ones who were accredited by the RSAC. Further, unjustified refusal of the tournament managers or technical officials shall be dealt with accordingly.
4. The participants of these activities are the RSAC, RSAC Data Group, Coaches, Athletes, Chaperons, and Field Technical Officials.
5. Food and lodging and accommodation expenses of the RSAC and RSAC Data Group shall be charged against funds allocated for screening and accreditation activities from the Central Office (CO), which were downloaded to the Division of Camiguin while travel and incidental expenses of the RSAC and RSAC Data Group shall be charged against their local funds, subject to the usual accounting and auditing rules and regulations.
6. This Office directs the immediate and wide dissemination of this Memorandum.
